- Annika opened up the committee meeting and gave the Antitrust Statement.

- For future committee meetings, did we want a virtual and/or in-person meeting during the AAAP meeting? The BOD is requesting that committees that can do virtual meetings before the AAAP meetings allows for less crowding and overlapping of other committee meetings that need to meet in person before/during AAAP meeting. Attendees suggested to do alternate virtual and in-person meetings before AAAP meeting and have virtual meetings throughout year (quarterly so next quarterly may be end of October or early November).
