**Briefly explain the topics discussed during your committee meeting**

4. Presentation by invited speaker Dr. Michele Jay-Russell, Program Manager/Research Microbiologist from the Western Center for Food Safety, University of California, Davis  
Dr. Jay-Russell's topic was "The Microbiological Hazards of Free-range Chickens and Wild Birds" (copy available upon request, file too big to attach)  
Dr. Jay-Russell talked about potential foodborne zoonotic pathogens focusing on Salmonella and Campylobacter. She also provided information about the multi-state outbreak of human Salmonella infections linked to backyard flocks in 2017. More discussion on the outbreak followed her presentation
5. Membership and Chair-elect issues - how can we get members to attend committee meetings? There are too many committee meetings going on at the same time. Can AAAP look into committee time slots to minimize overlap? Other committee members cannot travel to meetings every year.  
The issue of finding a chair-elect remain unresolved. The people who were approached declined.
6. We discussed the issue of separation from the Food Safety Committee and whether the separation should be maintained. Committee members suggested merging the two committee meetings if food safety issues are prominent in the public health discourse. The chair was tasked to discuss with James Barton, Chair of the Food Safety Committee (This was done and there is a tentative agreement to merge the two meetings next year and maybe extend the time to 2hrs.)
7. Communications: Suggestions to have at least 2-3 telephone conference calls a year to have more substantial discussions on important issues and initiatives
8. Goals for the year include;
  - improved and timely communications of emerging and zoonotic disease issues with members and with AAAP
  - Collaboration with committees with similar interests such as the Food Safety committee and the newly formed Small Flock committee
  - Chair should subscribe to other public health group listserves that are under the AVMA e.g American Association of Food Safety and Public Health Veterinarians and share some of their info with the committee
  - Invite speaker to annual meetings

The Food Safety and Inspection Service (FSIS) is announcing the availability of and requesting comment on guidance for importing meat, poultry, and egg products into the United States. This guidance is intended to help U.S. importers, customs brokers, official import inspection establishments, egg products plants, and other interested parties understand and comply with FSIS import requirements. Deadline for comments is September 5 and committee members will be asked to provide comments

The DPHS Committee organized the 2016 AAAP symposium "Emerging and Reemerging Zoonotic Diseases"

The symposium focused on avian influenza outbreaks, particularly HPAI H5N1 and recent outbreaks of H7N9 in China. The symposium also featured presentations on data collection and analysis for effective prevention and control of zoonotic diseases as well as communicating science-based information to non-scientists. The symposium concluded with a presentation on One Health

Collaborate with small flock committee to produce educational materials on zoonotic diseases, food safety issues and antibiotic use for small flock owners and veterinary practitioners
