The following two programs presently are in probationary status:

University Cal.-Davis- Program presently is inactive.

University Cal- Tulare – Program presently is changing to have a general pathology resident instead of a poultry resident; therefore the poultry program will close.

The following programs are active and up to date on their requirements:

NC State University- 3 students (Rosemary Matusek, Kabel Robbins, and Annika Hoffman). Program is active and up-to-date. The program is a 24 month degree program offering a non-thesis Masters of Specialty Veterinary Medicine (MSpVM). TOEFL (Test of English as a Foreign Language) scores GRE and admissions requirements for the Graduate School are required for admission to this program.

Cal. Animal Health & Food Safety Lab System- Includes the Turlock lab. TOEFL scores are not required for admission to this training program. They are currently seeking applications for a resident.

University of Georgia - 5 students; 2 finishing December 2009 (William "Drew" Parker, Natalie Armour) and 3 finishing December 2011 (Denise Brinson, Peter O'Kane and Rodrigo Espinosa). Program is active and up-to-date. The program is an 18 month degree program offering a non-thesis Masters of Avian Medicine (MAM). TOEFL scores are required for admission to this program; requires a minimum score of 80 on internet-based test (iBT).

University of Penn- No students currently due to funding, but program is active and up to date. TOEFL scores are not required for admission to this training program. There is a desire to restart the program but will be delayed due to budgetary constraints.

Miss. State University- 1 student (Josh Standridge [11]) and the program is active and up to date. TOEFL scores are not required for admission to this training program.

Ohio State University- 4 students Dr. Ahmed Ali is being trained in avian diagnostics, Dr. Kendra Walk and Dr. Jessica Simons are doing a poultry pathology PhD programs and Dr. Mohammad El-Gazzar is a PhD student and studying avian clinical and pathology. Program presently is active.

In accordance with the proposal adopted by the board per Dr. Tim Cummings in Jan. 1999, the five active programs have been reviewed by a committee member and have been found to be in compliance for the year 2010. The review documents have been placed in a file for each program and are held by the committee chair. At such time that programs in probationary status request reinstatement, programs will be reviewed again by a TPR committee member for compliance.
